# **Agency Relations:**

- Serve as a resource and liaison between Care and Share Food Bank and partner agencies
- Perform on-site agency monitoring visits once every two years to ensure safe food handling practices, compliance with Care and Share Food Bank policies, and the Agency Agreement
- Maintain on-going communication with all partner agencies through in-person visits, e-mail, and telephone calls
- Work with the Programs Director to develop strategies to recruit new and retain existing partner agencies
- Ensure partner agency electronic/hard copy records, files, databases, etc. are maintained and up to date with accurate information
- Collect agency statistics, ensure agency reporting, and maintain Access database with this information
- Annually review all agency documents (i.e. agency agreement, monitoring forms, food safety guidelines, etc...) and compare them
  with current requirements from Feeding America, federal and state regulatory agencies, and other industry best practices;
  Update documents as needed
- Lead monthly Shopper Orientation in the event Agency Relations Coordinator is unable to do so
- · Provide training and assistance to partner agencies to increase their capacity to provide food to hungry people
- Supervise the Agency Relations Coordinator and Agency and Programs Outreach Coordinator Positions
- Evaluate staff to ensure job objectives, strategic plan goals, and Within Reach goals are being met

## **Food Safety:**

- Manage Food Safety Training and ServSafe® certification for Care and Share staff
- Ensure that member agencies are properly trained in the fundamentals of food safety and ensure copies of their training certifications are maintained in agency files
- Facilitate monthly food safety training for Care and Share staff and maintain records of their attendance
- Calibrate temperature guns monthly and document results for Agency Relations and Programs
- Ensure all food safety recall announcements are forwarded to the Communications Director for posting on the Care and Share website

#### **Mobile Food Pantries:**

- Collect and record statistics for all mobile food pantries and maintain in a spreadsheet
- Observe/monitor mobile pantries periodically to ensure proper procedures are followed
- Train new mobile food pantry sites in proper procedures to run the pantry
