WHY INVEST?

At Care and Share Food Bank, we believe that no one should go hungry. Every day, we provide food to our partner agencies across Southern Colorado to serve families, children and seniors in need because well-fed communities are safer, more stable, and more vibrant for us all.

Care and Share exists to ensure that the one in seven Southern Coloradoans at risk of hunger have access to enough healthy and nutritious food to thrive. We know that children without adequate access to food cannot develop successfully, families cannot plan for their future, and seniors find it more difficult to remain independent.

Food aid to financially struggling working parents allows them to better focus on their work, other financial commitments and improving their current condition.

Assisting those in difficult straights fortifies their strength and will to overcome temporary challenges. Providing nutritious meals to seniors and people with disabilities helps them maintain personal dignity and or their health in the face of low fixed incomes.

HOW TO PARTICIPATE

To take advantage of this tax credit, your investment must be at a minimum of \$250 per donation in El Paso County and Pueblo County. You must pay by check or gifts of stock.

Make your donation or your company's donation payable to "El Paso County Enterprise Zone" or "Pueblo County Enterprise Zone" AND put Care and Share in the memo field.

Please indicate the last four digits of your social security number if making a personal donation or your company's EIN number if making a corporate donation.

Mail your check to Care and Share. After processing, the Enterprise Zone Administrator will mail you the Colorado tax credit certificate for use in filing your Colorado income tax return.

This program is one of the highest state tax credit programs in history.

Example | Donation: \$1,000

Federal Deduction \$300 (30% rate)

Colorado Deduction \$50 (5% rate)

Enterprise Zone Credit \$250 (additional 25% Colorado credit)

Net Cost of Donation \$400*

Gifts of stock are eligible for a 12.5% tax credit. Please contact us for more information.

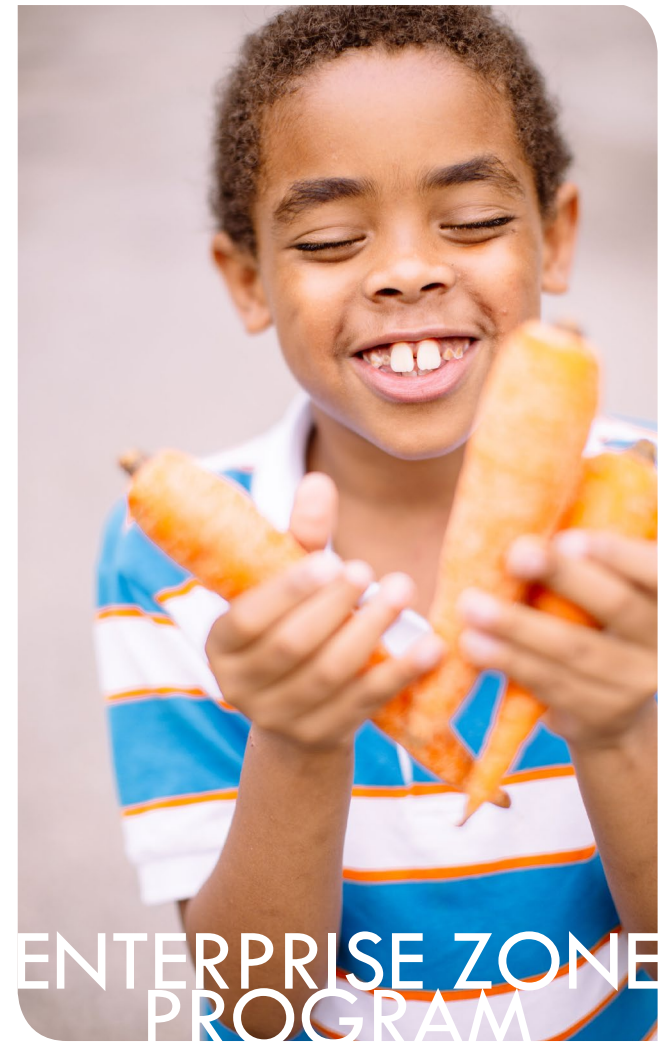
