This agreement specifies the rights and responsibilities of the above agencies as participants in the Commodity Supplemental Food Program (CSFP) This agreement is considered permanent, with amendments to be made as necessary, and may be terminated by either party upon 30 days written notice. By signing this agreement, both parties are bound by its terms and conditions.

The Subdistributing Agency agrees to:

- 1. Provide delivery of USDA Foods to the Recipient Agency without charge.
- 2. Provide training regarding CSFP requirements and offer training sessions and technical assistance to the Recipient Agency.
- 3. Ensure that all USDA Food packages comply with CSFP requirements.
- 4. Monitor Recipient Agency's distribution of USDA Foods according to CSFP requirements and do so during the Recipient Agency's normal hours of operation.
- 5. Ensure that the Recipient Agency meets all local and state health and sanitary code requirements applicable to food storage, transportation, and distribution.
- 6. Provide nutrition education to clients, including providing information on health, nutrition, and public assistance programs.
- 7. Notify Recipient Agency of their right to appeal any adverse action, in accordance with CSFP requirements.
- 8. Respond to Recipient Agency inquiries promptly, in accordance with CSFP requirements.
- 9. Take necessary steps to prevent and detect dual participation.

The Recipient Agency is delegated the following functions and agrees to:

Certify the eligibility of applicants who apply for USDA Foods and maintain the confidentiality of household information.
Notify CSFP applicants and participants of their rights and responsibilities.
Distribute the appropriate USDA Foods package to a CSFP participant based on their eligibility.
Prohibit certain activities at distribution sites that are unrelated to the distribution of USDA Foods.
Notify the Subdistributing Agency immediately if a participant fails to visit a distribution site for two consecutive months.
Allow representatives of the Subdistributing Agency, Distributing Agency, and USDA to review its site operations and records.
Attend training sessions required by the Distributing Agency and the Subdistributing Agency.

CSFP Agreement

Both parties agree to:

- Comply with CSFP federal regulations 7CFR 247, 7 CFR 250 as applicable including its referenced regulations, Federal-State Agreement for Child Nutrition and Food Distribution Programs, and State policy and procedures.
- Immediately report and accept full responsibility for any loss resulting from improper distribution and/or improper storage, care, or handling of USDA foods.
- Maintain accurate and complete records for a period of three (3) years from the close of the fiscal year to which they pertain, or longer if the records are related to unresolved claims actions, audits, or investigations.
- Ensure that all USDA Foods are distributed to eligible participants without regard to race, color, national origin, sex, age, or disability.
- Ensure that all volunteers and employees (including their supervisors) working directly with CSFP clients, receive annual Civil Rights training.
- Ensure the most current "And Justice for All" poster is posted for public visibility and that the current nondiscrimination statement is used on materials viewed by the public.
- Ensure that all public notifications regarding CSFP are published in English and Spanish and contain the USDA nondiscrimination statement.
- Comply with the Assurance of Civil Rights Compliance statement.

By accepting this assurance, the agencies agree to compile data, maintain records, and submit records and reports as required, to permit effective enforcement of nondiscrimination laws and permit authorized USDA personnel during hours of program operation to review and copy such records, books, and accounts, access such facilities, and interview such

personnel as needed to ascertain compliance with the nondiscrimination laws. If there are any violations of this assurance, the Department of Agriculture, FNS, shall have the right to seek judicial enforcement of this assurance. This assurance is binding on the agencies, its successors, transferees, and assignees as long as it receives assistance or retains possession of any assistance from USDA. The person or persons whose signatures appear below are authorized to sign this assurance on behalf of the agencies.

Certification: We, the undersigned, do hereby make and enter into this agreement. By so doing, we certify that the information contained in this document is true and correct to the best of our knowledge and is provided for the purpose of obtaining federal assistance. We do mutually agree to comply with the CSFP federal regulations 7CFR 247, 7 CFR 250 as applicable including all referenced federal regulations, Federal-State Agreement for Child Nutrition and Food Distribution Programs, and State policy and procedures. We understand that the deliberate misrepresentation or withholding of information may result in prosecution under applicable state statutes and federal regulations.
